

#### PRESIDENT'S MESSAGE

As the infrastructure and buildings in this country age and the loads we impose on them change, more importance is being placed on structure maintenance. Many jurisdictions in the



country are talking about creating and passing laws requiring periodic inspections of structures depending on their size, purpose, and age. Some jurisdictions, such as the State of Florida, have already passed these laws. The ICC is currently working on creating/editing an "ICC Condition Assessment Guide" which will outline what these building inspections need to include and lay the baseline for what is expected from the inspectors themselves in terms of liability, work product, and standard of care. Recently, I attended a NCSEA Existing Building Committee meeting to discuss the feedback that NCSEA will be submitting for this guide. The conversations are good, and I would strongly encourage anyone interested to reach out to NCSEA to get involved!

As more jurisdictions pass these laws and they start to take effect, the manpower required to inspect all the buildings that qualify will be massive! In response, NCSEA has started a subcommittee of the Existing Buildings Committee to create webinars to help train entry to mid-level structural



# **ONE RIVER NORTH TOUR**

### Philip Taylor SEAC Education Committee

Colorado's structural engineering community in April got an exclusive peek of one of Denver's most eye-catching new buildings. The 17-story One River North tower in the River North Arts District of north Denver is marked by its unique, multi-level reveal that resembles a sandstone slot canyon. SEAC members and industry partners on April 23 toured the newly opened residential high-rise and attended a special presentation by the building's key structural engineer and architect. Roughly 30 people attended the building tour and over 50 people attended the presentation at the Great Divide Barrel Bar nearby. More than 20 additional people, including roughly a dozen engineering students from Colorado State University, tuned into the presentation by webcast. The project's structural engineer, Austin Reese, P.E., of Jirsa Hedrick, highlighted the building's key gravity and lateral force resisting systems. The project's architect, Jason Bergfalk of Davis Partnership Architects, spoke about the building's unique nature-inspired features including the complex plaster system components, known by the project team as "chips." Many in-person attendees enjoyed a postpresentation social hour with their colleagues at Great Divide.


